Explanatory notes:

- All bonus and penalty payments are based on manufacturing milk.
- Arrabawn pay a 0.2c/l (ex VAT) bonus on all milk with an SCC less than 200,000.
- Arrabawn paid an input support payment in December of 1.422cpl (ex VAT)
- Aurivo have a milk storage bonus which is available to suppliers with a minimum annual supply of 160,000L that have enough refrigerated storage capacity to cover seven milking's at peak production. The storage bonus of 0.44cpl was taken from the "C" from September 2021. "C" is 3.813.
- Aurivo have a 0.21c/L (ex VAT) protein bonus available for every 0.05% protein achieved, above the co-op average protein %, in an individual month.
- Carbery Group pay a bonus of 0.5c/L (ex VAT) from March to October and a 0.88c/L (ex VAT) bonus from November to February to suppliers who achieve a somatic cell count (SCC) of less than 200,000.
- In September 2022, Carbery began to pay out a sustainability bonus of 0.5c per litre to farmers who have committed to Carbery's FutureProof program. The 0.5cpl is paid on all milk supplied in 2022 to farmers who have signed a sustainability pledge and agreed to undergo an ASSAP water quality assessment.
- Dairygold apply no penalties to total bacteria counts (TBCs) of less than 75,001 in the months of January, February, November, and December. Penalties will apply to TBCs more than 75,000 in those months.
- Dairygold have a 0.25c/L included and 0.1c/L for the Sustainable Dairy Assurance Scheme (SDAS), 0.1c/L for sign up to milk recording (four per year) and 0.05c/L for sign up to milk recording and a Munster Bovine herd health scheme; Dairygold also have a 0.04c/L maximum bonus attainable by farmers who achieve the minimum requirements for six criteria (TBC, thermoduric, sediment, SCC, lactose and inhibitors); This cumulatively amounts to 0.65c/l (ex VAT) .
- Dairygold have also agreed to pay 1cpl (incl VAT) in the December statement on all milk supplied in 2022.
- Lakeland Dairies are paying 1.422c/l (ex VAT) Input Support Payment for December. Lakeland also pay a Lactose bonus of 0.28cpl (incl. VAT)

- Lakeland have also agreed to pay 0.6cpl (incl VAT) in the December statement on all milk supplied in 2022.
- Lakelands pays a 4.73/L (ex VAT) bonus if more than 45% of May milk production was supplied in December.
- Kerry pays 0.4c/l (ex VAT) bonus on all milk with an SCC less than 200,000 and 0.1c/l (ex VAT) for SDAS.
- Kerry also paid a 1cpl (VAT incl.) on qualifying milk as part of their leading milk price.
- North Cork pay 0.2cpl (ex VAT) bonus on all milk with an SCC of less than 200,000.
- North Cork are paying 2c/l (ex VAT) bonus on all milk incl. Fixed Price Contracts for December.
- North Cork are paying 1c/l (ex VAT) input support payment for December.
- Strathroy pay 0.25c/l (ex VAT) bonus on all milk with an SCC of less than 200,000. Strathroy also pay 0.25c/l (ex VAT) bonus on all milk with an TBC of less than 10,000.
- Tipperary pay a bonus of 0.25c/l (ex VAT) on all milk with an SCC less than 250,000.
- Tipperary pay a 3c/L (ex VAT) if more than 15% of May milk production was supplied in December.
- Tirlán are paying an Agri Input Price payment of 6.16c/l (ex Vat) on all milk for December including Fixed Milk Contracts.
- Tirlán are paying a Sustainability Action Payment of 0.47 cpl (ex VAT) to be paid monthly on all milk supplied in 2022.
- Tirlán also pay a Seasonality Payment of 4 cpl (incl. VAT) on all creamery milk volumes supplied in December that meet quality criteria.
- Tirlán have also agreed to pay 1cpl (incl VAT) in the December statement on all milk supplied in 2022.
